3. The medals achieved at virtual exhibitions will not be considered for this purpose.
4. Please provide details of the recognized State Level Exhibitions only. The district and other level exhibitions will not be considered.
5. Have attended at least one juror seminar.
6. Able to write and speak fluently in English, with knowledge of English Philatelic terminology.
7. Have an up to date understanding of all FIP and Nationally recognized exhibition classes.
8. Be fully conversant with the FIP GREX, GREV, SREVs and Guidelines, and be prepared to implement them.
9. I will abide by the rules as laid down by PCI and changed from time to time and shall be governed by them.
