- 6. Answer all communications in a timely manner and coordinate with participants from India.
- 7. Be fully conversant with and be able to comply with the following procedures:
 - a) Obtaining Temporary Export Permit from the Archaeological Survey of India
 - b) Mandatory Permission from the Ministry of Culture,
 - c) Obtaining Insurance Policy
 - d) Customs formalities for both countries
 - e) Bank Transfer of participation fees
 - f) Liaison with India Post, if and when required
