EXTRACT OF RULES & REGULATIONS

RULE 2 MEMBERSHIPS

- A. The Membership of Congress shall consist of : (1) Institutional Members, (2) Life Members, (3) Associate Members.
- B. A Philatelic Society having 25 or more members will be eligible to become an Institutional Member of the Congress. The new members will be required to pay an admission fee of Rs. 5000, which will be treated as contribution to the Corpus of the Congress.
An annual subscription calculated at the rate of Rs. 50 in respect of each of its members, subject to a minimum of Rs. 5,000 up to 50 members and a maximum of Rs. 15,000 per annum shall be payable by all existing and new Institutional Members. The annual subscription for every membership year, along with a certified hard copy of the list of members and office bearers (with contact details) shall become due on 1st April of the relevant financial year.
- C. A Philatelist, who is resident in India, shall be eligible to be a Life Member of the Congress on payment of a consolidated membership fee of Rs. 20,000 payable with the application. The Senior Citizens of age 65 years and above will be allowed a rebate of 20% on the membership fee only on consolidated payment.
The membership fee may also be paid in three installments, Rs. 10,000 along with the application, second installment of Rs. 5,000 payable at the end of first year and third installment of Rs. 5,000 payable at the end of second year of the membership. In case the above membership fee including all installments is not paid within 4 years of the approval of the Life Membership, the Life Membership will stand cancelled and the entire amount received will be forfeited.
A Philatelist, who is a non- resident in India, shall be eligible to be a Life Member of the Congress on payment of a consolidated membership fees of US\$ 700 or its equivalent in foreign exchange with the application for membership.
The entire amount of the above Life Membership fees shall be treated as contribution to the Corpus of the Congress.
- D. Any person, who is resident in India or an institution in India, other than that specified in sub-para (b) above, interested in the art and science of philately shall be entitled to become an Associate Member of the Congress on payment of an admission fee of Rs. 500 and an annual subscription of Rs. 1500 per annum. The admission fee shall be treated as contribution to the Corpus of the Congress. The annual subscription for every membership year shall become due on 1st April of the relevant financial year. An associate membership will cease automatically on being in arrears of subscription or other dues for more than one year.
- E. Admission to membership shall be by application in the Prescribed Form submitted to the Secretary-General, subject to the applicable rules, verification and approval by the Governing Council which shall have the right to accept or reject the same. In case membership is approved prior to realization of the draft and it is not realized for any reason, whatsoever, the approved membership will become null and void.
- F. Any member guilty, in the opinion of the governing council of any misconduct, pertaining to philately, which is derogatory to his position as a member of the Congress, is liable to suspension or expulsion by a three quarters majority vote of the Governing Council. However, the expulsion shall be done only after giving the concerned member a show-cause notice in writing and providing him a reasonable opportunity to represent his case in defense.
- G. A member is entitled to resign his membership, provided he has paid all his dues up to date.
- H. Notwithstanding any other provisions of the Rules and Regulations, a member is liable to be expelled by a majority vote of the Governing Council, without prejudice to any rights of the Congress, if he is in arrears of subscription or other dues for more than one year.
- I. The resignation or termination of a membership, for any reasons whatsoever, shall be without prejudice to the rights of the Congress against the member in respect of his obligations to the Congress prior to his ceasing to be a member.
- J. The membership year of the Congress shall be from 1st April to 31st March of the subsequent year.
- K. Any amount paid towards admission fee, membership fee, subscription or any installments thereof shall not be refundable after the acceptance of a membership by the Congress, on resignation or termination of the membership for any reasons whatsoever.
- L. A member, who is in arrears of subscription, shall lose all his membership privileges, till he clears the arrears.
- M. The rights and privileges of a member shall be personal and not transferable.

Note: The above Membership fees and subscriptions are subject to change.
